FUNDING ALLOCATION FROM THE MUNICIPAL DISASTER RESPONSE GRANT (MDRG) FOR INFRASTRACTURE DAMAGES CAUSED BY DECEMBER 2023 TO JANUARY 2024 FLOODS AND STORM SURGES 2023/2024 FINANCIAL YEAR – APPLICATION FOR THE SHIFTING OF FUNDS BETWEEN APPROVED PROJECTS

My email dated 23 April 2024, bears reference.

Cederberg Municipality received an amount of R7 805 000.00 on 22 March 2024 for a total of 20 Projects. This forms part of the total approved allocation OF R16 370 000.00 for 5 (five) Municipalities in the Western Cape.

We acknowledge that funds should solely be utilised for approved project as stated in your Circular No 17 of 2024.

The Municipality advertised the approved projects through applicable procurement processes and the costing for all these tenders is much higher than projected. Due to this we need to shift and prioritise accordingly.

We hereby request that funds be shifted as follows:

The Citrusdal Borehole main water pipe that had been exposed, were closed and secured after the flooding by utilising own funding. The R200 00.00 will be utilised for preventative measures such as Gabions, Retaining Structures and fencing.

Clanwilliam WWTW suffered more stormwater damage after the submission of the original project list. We have two existing Contractors on site which has been appointed for the Refurbishment and Upgrading of the WWTW and we want to utilise the additional R600 000.00 to construct a more sustainable stormwater protection solution as well as additional fencing to secure the Works.

The above mentioned project enjoys priority as we are struggling to procure the necessary pumps and accessories due to our very limited budget. The prices received were almost double the approved amount.

We are scaling down on the Citrusdal WWTW project, as critical components will be identified and procured with the remaining balance of R312 824.00. This will not compromise the quality of the project, but the outstanding components are planned for contingency / standby purposes. Should additional funds be required, Cederberg Municipality will supplement the shortfall using other funding sources available. The WWTW are currently operating optimally and achieving effluent standards in line with DWS SANS241-1:2015.

We therefore require the shifting of funds in order to make the appointment of the Bid received for "CED 31/2023-2024: Supply, delivery and installation of sewer pump to various pumpstations and boreholes including all fittings (electrical and mechanical) in
