Tenders are hereby invited for the appointment of a panel for the abovementioned services.

Tender documents, in English, are obtainable from Thursday, 21 October 2021, at the reception of Cederberg Municipality, 2A Voortrekker Street, Clanwilliam, between 08:00 and 16:00 (Monday-Thursday) and Friday 08:00 -14:00 upon payment of a tender participation fee.

Payment of a non-refundable tender deposit of **R892.00** (VAT inclusive) is applicable. The amount must be deposited into Cederberg Municipality's account at Standard Bank, Branch Code: 05-0106, Account No: 082 163 324. The reference number when doing payment is: CED 16/2021-2022 – Company Name. Proof of payment is necessary when collecting tender documents.

Tenders, in sealed envelopes, clearly endorsed with: "**TENDER NO. Bids may only be submitted on the bid documentation issued by Cederberg Municipality.

The closing date and time of the tender is on **22 November 2021 at 12:00** and tenders will be opened in public immediately thereafter in the Supply Chain Management Committee Room, Clanwilliam Administration.

Tenders must be valid for a period of 90 days after the closing date. The tender will be evaluated according to the 80/20 Preference Points System, as prescribed by the Preferential Procurement Regulations, 2017.
